<sup>&</sup>lt;sup>2</sup>In 16 pt., bold font, not in capital letters. Write a title for your paper which includes the most important keywords related to the Conference topic.

<sup>&</sup>lt;sup>3</sup> In 12 pt., bold font, not in capital letters.

<sup>&</sup>lt;sup>4</sup> In 12 pt. Please provide the affiliation of each author (full name of your university or institution, its department and full address).

<sup>&</sup>lt;sup>5</sup> Abstract text is written in 10 pt.

<sup>&</sup>lt;sup>6</sup> In 10 pt. Please provide up to 10 keywords, indicating the essential topics of your research.

<sup>&</sup>lt;sup>7</sup> In 12 pt., bold font. The paper begins with an Introduction. It should clearly state the purpose and objectives of the research. A well-written introduction engages the reader in the problem of interest and provides a context for research by placing the paper in the context of current knowledge and prior theoretical and empirical research related to the topic.

<sup>&</sup>lt;sup>8</sup> In 12 pt. Following the Introduction, text should be organized into logical parts and sections that present research findings. Headings must be concise, in bold font.

<sup>&</sup>lt;sup>9</sup> Figures should be captioned below in 10 pt. (for instance: Figure 1. Title of a Figure) and centered under the figure. Tables should be captioned above a table (for instance: Table 2. Title of a Table.) and centered to the left.

<sup>&</sup>lt;sup>10</sup> Conclusions should describe research results and discussion, the interpretation of these results, and the conclusions that can be drawn. The authors might also discuss potential future directions for research.

<sup>&</sup>lt;sup>11</sup> Within the article text, references are cited giving the last name of the author(s) and the year of publication of the reference. The year should always be enclosed in parentheses; whether or not the name of the authors(s) should be enclosed within the parentheses depends on the context. For instance, Last name (Year) or (Last name, Year). The list of references at the end of the paper should be arranged in an alphabetical order in accordance to the last name of the author. Please refer to the reference examples shown above.

Please make sure that your reference list is presented in an APA 6 th edition style arranged in an alphabetical order in accordance to the last name of the author or source. Just for your primary reference, we provide several examples below:
